

RULES AND REGULATIONS OF 'I recommend Dimedic. Benefits go to me and my friends' SPECIAL OFFER

I. The organizer of the Special Offer

1. The Special Offer is organized by DiMedic Limited seated in Newcastle upon Tyne, 104 Close, Quayside NE1 3RF, United Kingdom, registered in the Companies House under the number 09290911, hereinafter 'Dimedic' or 'the Organizer'.
2. The Special Offer may not be joined with other special offers organized by Dimedic.

II. Terms of participation in the Special Offer

1. The Special Offer is addressed to the registered and new users of dimedic.eu.
2. A person participating in the special offer becomes its Participant, hereinafter 'a Special Offer Participant'
3. The Special Offer consists in Dimedic providing each registered user with a personalized Individual Code to be used to share with a non-registered user. As part of the promotion, Individual Codes provided to unregistered users by Dimedic's partners are also honored.
4. A person who shares the Individual Code to a person not registered on dimedic.eu and a person who registers on dimedic.eu with the use of the received Individual Code becomes a Special Offer Participant.
5. Participation in the Special Offer means acceptance of all terms of these Rules and Regulations.
6. Participation in the Special Offer is voluntary.

III. Term of the Special Offer

1. The Special Offer starts on 19 May 2017 and ends on 30 September 2022 included.
2. The discounts collected throughout the special offer may be used for 2 years after being granted.

IV. Terms of the Special Offer

1. A registered user of Dimedic is sent, electronically at the e-mail they provided and to their Individual Account on dimedic.eu, a personalized Individual Code to be used to share with a non-registered user.
2. Each registered user of Dimedic may share their personalized Individual Code to any number of people who are not the users of dimedic.eu.

3. The Individual Code may be provided in any way, with the proviso that it is unacceptable to provide it via entries placed in profiles / accounts in social media belonging to the Organizer, including the messages placed there; all such entries with content containing an Individual Code will be deleted by the Organizer.
4. If a person who has not been a user of dimedic.eu before registers with the use of the Individual Code, they get a discount of £5 (five pounds), which will be deducted from the cost of the next online medical consultation. Such person becomes a Special Offer Participant upon the moment of registering as a user of dimedic.eu.
5. A person who is a user of dimedic.eu and who shared the Individual Code gets a discount of £5 (five pounds) upon the moment the recommended person has a consultation with the use of the Individual Code provided to them.
6. Special Offer Participants may use the discounts in order to reduce the cost of online medical consultations provided by Dimedic.
7. Discounts resulting from the sharing of the Individual Code are cumulative.
8. The amounts of discounts resulting from the shared Individual Codes may be used by a Special Offer Participant in order to pay for online consultations provided by Dimedic not later than 2 years after the day of being granted the discount. After the lapse of this term the unused discounts are cancelled.
9. Dimedic reserves the right to freeze the Individual Account and/or take the discounts away if there is a reasonable suspicion that they have been obtained in an illegal way.
10. Dimedic reserves the right to verify the granted discounts.

IV. Complaints

1. Complaints related to the Special Offer may be filed by the user in writing within 30 days of the lapse of the validity period of the granted discounts.
2. The complaint must include a statement of grounds.
3. Complaints will be processed by Dimedic within 30 days of their receipt.
4. The Special Offer Participant will be informed about the result of complaint proceedings in writing. The decision of Dimedic is final. This does not exclude the rights of the Special Offer Participant to enforce their claims under the applicable provisions of the law.

V. Final Provisions

1. These Rules and Regulations are the only document specifying detailed rules of the Special Offer.
